MOTION TO WITHDRAW PETITION


Now comes Spark Energy, LLC ("Spark" or "Petitioner"), formerly known as Spark Energy, LP ("former entity"), and for its Motion to Withdraw Petition, state as follows:

1. On August 13, 2014, Spark filed its Petition to Change Corporate Form. Spark was seeking to petition the Illinois Commerce Commission ("ICC" or "Commission") to update the former entity's certificate of authority to operate as an Alternative Retail Electric Supplier ("ARES") to reflect the changed name of the Petitioner.
2. On September 15, 2014, Spark was notified that its request that the former entity's certificates be canceled and re-issued in the name of the Petitioner (i.e., Spark Energy, LLC) via Petition was invalid. Spark will now re-submit its license application acknowledging its corporate structure change along with any applicable updates (i.e., technical, financial and managerial qualifications, financial qualifications, etc...).

Wherefore, for the reasons stated above, Spark respectfully request the Petition filed in the above-captioned proceeding be withdrawn and the matter now closed.
