- Q: PLEASE STATE YOUR NAME AND BUSINESS ADDRESS FOR THE RECORD.
- A: Fernando Bueno, 1511 N. Westshore Boulevard, Suite 750, Tampa, Florida 33607
- Q: BY WHOM ARE YOU EMPLOYED AND IN WHAT CAPACITY?
- A: I am the Financial Controller of MTI (USA) LLC.
- Q: IS THE ADDRESS OF THE COMPANY THE SAME AS THAT WHICH YOU HAVE JUST SUPPLIED?
- A: Yes.
- Q: PLEASE DESCRIBE YOUR DUTIES FOR THE COMPANY.
- A: As Financial Controller, I oversee and manage all aspects of the day-to-day accounting and finance responsibilities of the Company.
- Q: PLEASE PROVIDE A BRIEF BACKGROUND ON YOUR EXPERIENCE IN TELECOMMUNICATIONS.
- A: I have held a variety of positions in various businesses, including manufacturing, government and telecommunications. My business experience includes management positions with supervisory authority in internal account management, customer billing, staff supervision, bookkeeping and regulatory liaison with local compensation boards and state commissions. Given my extensive experience I believe I was well suited to perform

the business and accounting obligations of MTI (USA) LLC in its provision of prepaid telecommunications services.

Q: ARE YOU FAMILIAR WITH THE APPLICATION YOUR COMPANY SUBMITTED TO THIS COMMISSION?

A: Yes.

Q: DO YOU RATIFY AND CONFIRM THE STATEMENTS AND REPRESENTATIONS MADE IN THAT APPLICATION?

A: Yes.

Q: WHAT IS THE OWNERSHIP STRUCTURE OF MTI (USA) LLC ("MTI")?

A: MTI is a limited liability company formed under the laws of the State of Delaware.

Q: WHAT SERVICES ARE PROVIDED BY MTI?

A: MTI provides prepaid calling card services.

Q: HOW WILL MTI BILL ITS CUSTOMERS?

A: MTI provides prepaid services which means the customer pays for the minutes of service prior to having access to use the service.

Q: HOW WILL MTI HANDLE CUSTOMER COMPLAINTS?

A: MTI's Customer Care representatives are available during normal business hours, as well as 24-hour automated customer assistance, which will allow customers to bring service, billing and repair questions or complaints to the Company's attention 24 hours a day, 7 days a week, facilitating the quick and efficient resolution of Customer concerns. Customers may access Customer Care through MTI's toll-free customer service number to initiate service complaints or to receive updates on reported problems or pending requests. Inquiries regarding service or billing may also be made in writing. Customers

may thereafter utilize the Company's automated update system or transfer to a Company representative for additional information or assistance.

Q: HOW LONG HAS MTI BEEN IN BUSINESS?

A: MTI has been in business since August 21, 2013.

Q: DOES MTI HAVE OFFICES IN ILLINOIS?

A: No. MTI does not intend to have an office physically present in Illinois at this time. Accordingly, MTI requests a waiver of Part 250 of 83 Illinois Administrative Code to allow it to maintain its books and records at its principal office located at 1511 N. Westshore Boulevard, Suite 750, Tampa, Florida 33607. In the event that the Commission should desire to inspect such books and records, MTI will provide access expeditiously at its own expense.

Q: WHY HAS MTI FILED THIS APPLICATION?

A: MTI's telecommunications offerings will be beneficial to Illinois consumers and, in particular, that segment of the consuming public which seeks another affordable choice when utilizing long distance calling services.

Q: DOES MTI PROVIDE CONVENTIONAL OR ALTERNATIVE OPERATOR SERVICES?

A: No.

Q: DOES MTI PROVIDE PAYPHONE SERVICE?

A: No.

Q: WILL MTI SERVE RESIDENTIAL USERS?

A: Yes.

Q: DO YOU BELIEVE THAT YOUR PRINCIPAL MANAGERIAL AND TECHNICAL PERSONNEL HAVE THE QUALIFICATIONS AND TECHNICAL ABILITY NECESSARY TO PROVIDE THE PROPOSED LOCAL EXCHANGE SERVICES?

A: Yes, I do. Attached to MTT's application for authority are brief biographies of personnel which demonstrates MTT has competent and experienced management with ample technical telecommunications experience to provide successful and continuous telecommunications services in Illinois.

Q: DOES MTT HAVE THE FINANCIAL QUALIFICATIONS TO OPERATE AS A CARRIER IN ILLINOIS?

A: Yes. As demonstrated by the financial statements attached to MTT's Application, the Company has the financial resources necessary to provide reliable prepaid telecommunications services to residents of the State of Illinois.

Q: IN YOUR OPINION, WOULD GRANT OF MTT's APPLICATION BE IN THE PUBLIC INTEREST?

A: Yes. MTT's proposed service will provide prepaid telecommunications services of the highest quality, will provide increased consumer ability to determine the payment options best suited to their situations, and will offer increased diversification and increased reliability of communications services. Grant of the Company's Application will enhance competition for interexchange telecommunications services in this state by providing consumers with an additional service provider choice for the satisfaction of their long distance telecommunications needs.

Q: DOES THIS COMPLETE YOUR PREFILED TESTIMONY IN SUPPORT OF YOUR APPLICATION?


A: Yes, it does.
