### **Vice President of Natural Gas – Mr. Grant Christman**



In his role as Vice President, Mr. Christman oversaw all day-to-day natural gas operations including managing internal sales representatives, communicating with external sales reps and third party acquisition channels (brokers, telemarketers, etc.), deal pricing, deal contract negotiation and structuring, natural gas procurement, risk management, marketing strategy, and regulatory. While at Border, Mr. Christman led a team of three analysts, two sales reps and internal as well as shared internal and external IT personnel. Prior to his role as Vice President, Mr. Christman had the hands on responsibility of running the day-to-day operations of the company, including scheduling on interstate pipelines and on LDC EBB’s, managing and completing storage injections and withdrawals according to a wide variety of different storage operator requirements/schedules, completing capacity releases and re-releases to third parties, load forecasting and shaping, and the procurement of natural gas supplies from upstream providers. ## Mr. Andy Mitrey, MBA – President

Mr. Andy Mitrey serves as the President of Archer Energy, LLC. In this capacity, he oversees all day-to-day activities of the business. Archer Energy, LLC was formed in late 2014 by Mr. Mitrey. Prior to forming Archer Energy, Mr. Mitrey was the president of Border Energy, Inc., a certified provider of natural gas and electricity to residential and commercial customers across Indiana, Michigan and Ohio. Mr. Mitrey spent 10 years at Border Energy and oversaw all of its day to day operations and owned 25% of the company. Mr. Mitrey has spent time in all areas of the natural gas business. He purchased all of the natural gas and basis needs for their customers across three states, negotiated with suppliers for favorable terms, determined the company's mass marketing strategy and interacted with regulators on any regulatory issues. In early 2014, Mr. Mitrey's partner decided that he wanted to exit the business and Mr. Mitrey worked with investment bankers and potential purchasers to structure a deal that sold the company to IGS Energy. The sale closed in late September 2014.

Mr. Mitrey has more than 19 years of experience in the energy industry with 10 of them directly related to serving end use customers through a customer choice program. Prior to that Mr. Mitrey worked in the corporate risk department at American Electric Power where he oversaw the credit risk associated with the wholesale natural gas and trading operations. Mr. Mitrey is also extremely familiar with establishing banking relationships as prior to joining American Electric Power, he was a commercial loan officer for PNC Bank. In that capacity Mr. Mitrey provided loans to energy, metals and mining companies. Mr. Mitrey has an undergraduate degree in accounting and an MBA from The Ohio State University.

Mr Andrew Ernst serves as the Vice President of Finance for Archer Energy, LLC. Mr Ernst joined Archer in 2015 to handle all financial aspects of the business.
