MOTION FOR CONFIDENTIAL TREATMENT AND PROTECTIVE ORDER

MP2 Energy NE LLC. (MP2) hereby petitions the Illinois Commerce Commission ("Commission") for confidential treatment for a period of not less than two (2) years of confidential and proprietary information contained in the ARES Report of Part 451 Continuing Compliance.

In accordance with 83 Ill. Adm. Code Section 451.60 provides: "If an applicant or ARES believes any of the information to be disclosed by an applicant of ARES is privileged or confidential, the applicant or ARES should request that the Commission enter an order to protect the confidential, proprietary or trade secret nature of any data, information or studies pursuant to 83 Ill. Adm. Code 200.430."


Specifically, MP2 requests that the Commission issue an order requiring confidential treatment for:

- Confidential Attachment 1 – Financial Reporting Requirements
- Confidential Attachment 3 – Managerial Reporting Requirements
- Confidential Attachment 4 – Technical Reporting Requirements
- Confidential Attachment 5 – License or Permit Bond

MP2 believes the aforementioned information to be highly proprietary, and if disclosed could lead to competitive harm to MP2. Section 7(g) of the Illinois Freedom of Information Act exempts from public disclosure "trade secrets and commercial or financial information obtained from a person or business where the trade secrets or commercial or financial information are furnished under a claim that they are proprietary, privileged or confidential, and that disclosure of the trade secrets or commercial or financial information would cause competitive harm to person or business, and only insofar as the claim applies to the records requested.

It is the belief that the contained documents are competitively sensitive and/or employee specific and will not advance the public's understanding of MP2.


