Pursuant to 83 Ill Code Part 451, Hudson Energy Services, LLC. d/b/a Hudson Energy ("Hudson Energy") an Alternative Electric Supplier certified under Illinois Commerce Commission ("ICC") Docket No. 07-0455 seeks to file a report with the Chief Clerk of the Commission no later than March 1 of every year stating the total annual kilowatt-hours delivered and sold to retail customers in all utility service territories in the preceding calendar year.

Hudson Energy delivered and sold [REDACTED] kilowatt-hours to retail customers during the 2014 calendar year. All retail sales and deliveries by Hudson were in the Commonwealth Edison utility service territory.
