RESPONDENT'S MOTION FOR CONTINUANCE

Now come the Respondent, Commonwealth Edison Company ("Respondent" or "ComEd"), by its attorney, Mark L. Goldstein, and moves the Administrative Law Judge ("ALJ") to continue the filing of exceptions to the Proposed Order in the captioned matter, and in support thereof, states:

1. On May 4, 2015, the Administrative Law Judge ("ALJ") had a Proposed Order issue wherein Briefs on Exceptions were due on May 18, 2015.
2. On or about May 4, 2015, Erin Buechler, Senior Regulatory Specialist and ComEd's attorney contact at ComEd took another position with ComEd and thus, the ComEd attorney as outside counsel, was unable to get authority to respond to the Proposed Order.


