
Providing a Helping Hand to customers in need

Starting April 18, ComEd will begin accepting applications for the Helping Hand program. Enrollment will continue until May 13, or until funds are depleted. The Helping Hand program is designed to provide immediate relief to residential customers in need who have received a disconnection notice or who have been recently disconnected. Qualifying customers could be eligible for a one time grant up to 50% of the disconnect notice or final bill amount, whichever is applicable.

Once required documentation has been approved by the agency, the following actions will be taken

- Customers must pay 50% of disconnect notice or final bill amount. The Agency will determine payment amount once the application is accepted
- ComEd will set aside the remaining 50% balance of the disconnect notice or final bill amount for the duration of the program.
- Customers are then required to make three consecutive on time payments for the full amount of their monthly bill, not including the "set aside" past due amount.

Customers who successfully complete the program will be awarded a Helping Hand grant for the remaining 50% of their disconnect notice or final bill amount that was previously set aside. Grants will be applied to the customers account during the fourth month after program enrollment.

PROVIDING a HELPING HAND to GOD'S people in need

Starting now Grace Bible Center is accepting applications for Grace Bible Center/Watch Care utility program. Enrollment will continue until funds are depleted.

The Grace Bible Center/Watch Care's program is designed to provide immediate relief to residential people in need who has received an expired disconnection notice or who have been recently disconnected. When you qualify you could be eligible for a one time grant up to 50% of the expired disconnection notice or final bill amount, whichever is applicable.

Once required documentation has been approved by Grace Bible Center, the following actions will be taken:

- You must donated a percentage % of the expired disconnect notice or final bill amount. Grace Bible Center will determine percentage amount once the application is accepted.
- Grace Bible Center will set aside **FUNDS** for the remaining 50% balance of the expired disconnect notice or final bill amount for the duration of the program.

When you successfully complete the program you will be awarded a Grace Bible Center/Watch Care Grant for the remaining 50% of your expired disconnect notice or final bill that was previously set aside. Grants and your original donation/pledge will be applied to your account during the seven month after program enrollment.

- You will be given a second chance – Have to make 10 consecutive payments. On 11th payment old bill is zeroed out.
