MOTION TO WITHDRAW PETITION AND TERMINATE DOCKET

Now comes XO Illinois, Inc. (“XO”) by its attorneys, and pursuant to 83 Ill. Admin. Code 200.190, moves to withdraw the petition initiating this proceeding and moves that the Commission terminate this docket. In support of this motion, XO states as follows:

1. On June 25, 2001, XO initiated this proceeding by filing a petition pursuant to Section 252(b) of the federal Telecommunications Act of 1996 (“Federal Act”) for an arbitration of the interconnection agreement between XO and Ameritech Illinois (“Ameritech”).
2. Pursuant to the Commission’s rules of practice for arbitration proceedings, 83 Ill Admin. Code 761, the parties have submitted evidence and briefs and a Proposed Arbitration Decision has been issued by the Administrative Law Judge.
3. XO and Ameritech have reached an agreement on all issues subject to arbitration. They therefore wish to terminate this proceeding and then initiate a new proceeding, pursuant to section 252(e) of the Federal Act, for approval of their

negotiated interconnection agreement..

4. Counsel for Ameritech and for the Staff of the Commission consent to the withdrawal of the petition initiating this proceeding and consent to the Commission terminating this docket.

WHEREFORE for the reason stated above, XO Illinois, Inc. moves the Commission allow it to withdraw its petition filed on June 25, 2001 initiating this proceeding and that the Commission terminate this docket.
