VERIFIED PETITION TO INTERVENE  
OF  
MIDAMERICAN ENERGY COMPANY

NOW COMES, MidAmerican Energy Company ("MidAmerican") and, pursuant to 83 Illinois Administrative Code Section 200.200, petitions the Illinois Commerce Commission ("Commission") for leave to intervene in the above-captioned proceeding and, in support of this petition, states as follows:

1. MidAmerican is an Iowa corporation, having an office at 666 Grand Avenue, P.O. Box 657, Des Moines, IA 50303-0657. MidAmerican is engaged in the business of generating, transmitting and distributing electric energy, and distributing and transporting natural gas in portions of the State of Illinois and elsewhere and is a public utility within the meaning of the Illinois Public Utilities Act (Act), 220 ILCS 5/1-101, et seq.

2. On June 27, 2001, the Illinois Commerce Commission (ICC) issued an Order suspending the Peoples Gas Light & Coke Company's proposed revisions to riders SVT, AGG, Rider 2, Terms and Conditions, and Table of Contents.

3. As an Illinois public utility engaged in the business of distributing and transporting natural gas in Illinois, MidAmerican has a direct and substantial interest in the subject matter of this proceeding. MidAmerican is also actively participating in the Illinois market as a gas supplier in both the Peoples Choices For You program and the NICOR Customer Select program. Decisions made in the instant proceeding could affect MidAmerican's interests as an electric utility and as an alternative electric supplier.

4. No other party to this proceeding can adequately represent MidAmerican's interests.

5. The granting of MidAmerican's Petition to Intervene will not delay this proceeding as MidAmerican intends to participate on the single issue of Supplier Single Billing based on the testimony in the record.


