Errata and Corrected Direct Testimony

Dear Ms. Rolando:

On April 15, 2015, Commonwealth Edison Company (“ComEd”) filed with the Illinois Commerce Commission its Direct Testimony in the above-referenced docket. These errata correct the Direct Testimony of Christine M. Brinkman, ComEd Ex. 1.0, attached to that testimony. The revisions to Ms. Brinkman’s testimony (ComEd Ex. 1.0 CORR.) are as follows:

- In header, add “CORR.” after “ComEd Ex. 1.0”
- On cover page, add “Corrected” before the word “Direct”
- At lines 581-582, change “Long Term Performance Share Awards Program (“LTPSAP”)” to “long term incentive programs offered to executives below senior vice president”
- At line 612, add “below Senior Vice President” after “Executives”
- At line 617, change “LTPSAP” to “executive long term incentive programs offered to executives below senior vice president”
- At line 619, change “Executives” to “executives”
- At line 650, add “below senior” before “vice president”
- At line 651, delete “and above”
- At line 652, add “to executives below senior vice president” after “LTPSAP”
- At lines 653-654, replace “in part by adding” with “as ComEd added these” and replace “in part by offering” with “offered”
- At lines 656-657, add “In 2014, did ComEd provide an incentive plan for its executives (senior vice president and above) similar to the 2013 LTPSAP?”
- At lines 658-659, add “Yes. In 2014, ComEd did provide the LTPSAP to executives at the senior vice president and above level. The metrics for the 2014 LTPSAP were the same as the 2013 LTPSAP.”

- At line 664, add “and the 2014 LTPSAP” before “program”
- At line 664, change “program” to “programs”
- At line 667, change “3.1” to “2.3”
- At line 667, add “, and \$0.8 million related to the 2014 LTPSAP” after “2014”
- At line 668, add “and 2014 LTPSAP” after “2013 LTPSAP”
- At line 670, delete “payout”
- At footnote 4, replace “ComEd has previously offered an additional program, discussed in Sections V.D. That additional program was not offered in 2014” with “Executives below senior vice president are eligible to participate in the LTPP and the LTPCAP. ComEd has previously offered different programs for these employees, the Executive Long Term Share Aware Program (“LTPSAP”) discussed in Section V.D and the Restricted Stock Unit Program (“RSU”). These programs were not offered to executives below senior vice president in 2014.”

For the purpose of clarity, ComEd is refiling the testimony in its entirety as ComEd Ex. 1.0 CORR.
