PETITION TO INTERVENE OF THE CITY OF CHICAGO

Pursuant to Section 200.200 of the Rules of Practice of the Illinois Commerce Commission (83 Ill. Admin. Code §200.200), the City of Chicago (the "City"), a municipal corporation of the State of Illinois, by its attorney, Mara S. Georges, Corporation Counsel, respectfully seeks leave to intervene in the above-captioned proceeding. In support of its Petition for Leave to Intervene, the City states as follows:

1. Pursuant to Section 10-108 of the Public Utilities Act (the "Act"), the City is entitled to appear as of right in proceedings before the Commission. 220 ILCS 5/10-108. To expedite its participation in this proceeding, the City is submitting this Petition to Intervene.
2. The City and its residents and businesses are utility consumers. The City's Law Department represents these consumers to ensure that their utility rates and services comply with the dictates of the Act.
3. The City and its residents and businesses have a direct interest in, and may be affected by, the determinations of the Commission in this proceeding.
4. No party to this proceeding can adequately represent the City's interests.
