**SUPPLEMENTAL COMPLIANCE FILING OF GRAIN BELT EXPRESS CLEAN LINE LLC
TO ADMINISTRATIVE LAW JUDGE’S RULING DATED JULY 31, 2015**

On July 31, 2015, the Administrative Law Judge issued a ruling (“ALJ Ruling”) requesting Grain Belt Express Clean Line LLC (“Grain Belt Express”) to provide certain information as a compliance filing. Grain Belt Express filed this information on August 12, 2015 in the above-referenced Docket.

On August 19, 2015, the Administrative Law Judge requested Grain Belt Express Clean Line LLC (“Grain Belt Express”) witness Timothy Gaul to provide information about landowner objections or requests made to the Proposed Route and the Alternate Route at Local Public Hearings, which were held by the Illinois Commerce Commission on July 28 and 29, 2015.

Grain Belt Express provides the following supplemental response to the ALJ Ruling, as directed by the Administrative Law Judge on August 19, 2015.

- (1) Supplemental Attachment 4 provides a list, by Tax ID Number, of each parcel on the Proposed Route for which the landowner has made specific objections or proposed changes to the route during the Local Public Hearings.
- (2) Supplemental Attachment 5 provides a list, by Tax ID Number, of each parcel on the Alternate Route for which the landowner has made specific objections or proposed changes to the route during the Local Public Hearings.


