**VERIFIED PETITION TO INTERVENE OF
ETHICAL ELECTRIC, INC.**

Ethical Electric, Inc. ("Ethical"), by its undersigned attorney and pursuant to 83 Ill. Admin. Code § 200.200, hereby respectfully petitions the Illinois Commerce Commission ("Commission") for leave to intervene and participate as a party in this docket. In support of its Verified Petition to Intervene, Ethical states as follows:

1. Ethical is a corporation organized and existing under and by virtue of the laws of the State of Maryland, with its corporate offices at 1055 Thomas Jefferson St. NW, Washington DC 20007. Ethical is a Retail Electric Supplier ("RES") as that term is defined in 83 Ill. Admin. Code 453.10.

2. On September 10, 2015, this docket was initiated by the Commission as a result of a Staff Report dated August 24, 2015, wherein Staff of the Commission recommended the Commission initiate a rulemaking in which the Commission may consider amending its administrative rules to address the marketing practices of a RES.

3. Prior to initiating this proceeding, the Commission initiated a Notice of Inquiry ("NOI") in 2014, under which it sought comments on various matters relating to marketing practices used by retail electric suppliers in Illinois.

4. Ethical has an interest in the subject matter of this docket, and cannot be adequately represented by any other party in this case.






