**MOTION FOR COMMISSION REFEREED METER TEST**

The Complainant, Maria Bobak, by and through her attorneys Ziccardi Law Offices and pursuant to Illinois Administrative Code 83, 410.190(d), hereby request Commission referred meter testing of meter no. 9994925560. In support thereof, Bobak states as follows:

1. Bobak filed a formal complaint against Commonwealth Edison ("ComEd") on or about August 13, 2015 alleging excessive billing and requesting a credit.
2. In early 2015, ComEd determined that Meter No. 9994925560 was not properly registering the electricity used and said meter was replaced. ComEd subsequently assessed a billing adjustment against Bobak in the amount of \$1716.24.
3. Bobak now seeks Commission refereed testing of said meter to determine whether said meter was not registering all electricity properly as alleged by ComEd.

Wherefore, the Claimant Maria Bobak hereby respectfully requests Commission refereed testing of meter no. 9994925560, and grant such other as deemed appropriate.




