Notice of Withdrawal of Registration**

To the Commission:

Pursuant to 83 IL Adm. Code 454.40, EnerNOC, Inc. ("EnerNOC"), on behalf of its wholly owned subsidiary, World Energy Solutions, Inc. ("World Energy"), hereby requests withdrawal of World Energy's Registration as an ABC. It is the intention of EnerNOC to merge World Energy with EnerNOC on or about January 1, 2016 with EnerNOC becoming the surviving entity.

EnerNOC acquired World Energy on January 5, 2015 and a letter of notice was submitted to the Commission on the same day. EnerNOC was granted its ABC Registration, docketed as 11-0701, on February 16, 2012. As brokers and consultants, neither World Energy nor EnerNOC takes title to energy and does not service customers as an energy supplier. Therefore, no energy supply service contracts will need to be transferred. Since World Energy will be fully integrated into EnerNOC, EnerNOC will not make any distinction between former World Energy customers and customers who contracted directly with EnerNOC. Additionally, all customers will receive the same service level and have access to EnerNOC's toll free 1-800 number if they are unable to contact their dedicated account manager.
