NOTICE OF ADMINISTRATIVE LAW JUDGE'S RULING dated 10/1/2015

Dear Ms. Rolando:

1. Applicant shall furnish proof of publication of notice of its application in the official state newspaper, pursuant to 83 Ill. Adm. Code 451.30(a).

*Astral Energy has provided the proof publication under separate cover.*

2. Applicant shall furnish a Corporate Organizational Chart, pursuant to 83 Ill. Adm. Code 451.340(b).

*Jason K. Fox, President/Chief Executive Officer – Responsibilities: financial administrative oversight*

*Ashton D. Fox, Chief Operating Officer – Responsibilities: dealing with energy suppliers, trading partners, daily operations.*

*Noah Isaacs, Controller – Responsibilities: cash remittances, payroll, payables.*

*Shi-Ru Lin, Contract Administrator – Responsibilities: Licensing, interface with utilities.*

*Elizabeth Badillo, Esq., Compliance Manager – Responsibilities: working with each state licensing organizations, customer complaint resolution.*

3. Applicant states in ¶14 of the application that it “seeks to be authorized to offer service throughout the Commonwealth Edison service area.” Applicant also states in ¶14(c) and in the last sentence of the application that Applicant intends to service customers throughout both the Commonwealth Edison and the Ameren Illinois service areas. Applicant further notified Ameren Illinois’ designated agent of its intent to offer service in the Ameren Illinois service area. Applicant shall provide a full explanation of precisely in what utility’s or utilities’ service area Applicant intends to provide service.

*Please note that Astral Energy LLC at this time only want to provide service throughout the Commonwealth Edison service area. Astral inadvertently in its initial application listed Ameren Illinois service area. Astral at this time has no intention to service the geographic covered by Ameren.*

4. Applicant shall identify, pursuant to 83, Ill. Adm. Code 451.330(b), at least one individual on its staff who has at least four years experience buying and selling power and energy in wholesale markets and at least one year of scheduling experience working for an entity that is either a member of PJM, a market participant in Midwest ISO, or has a system operator certificate from NERC, or has earned Certified Energy Procurement Professional status by the Association of Energy Engineers or equivalent certification.

*Astral Energy utilizes the services of GP Renewables & Trading LLC. As such GP has over 12 years of experience in buying and selling power in the wholesale markets, and at least one year of scheduling experience with an entity that is a member of PJM. Please see resumes of Gabriel Phillips, Jonathan Spivak, and Alex Baldassano.*

5. Applicant shall list, pursuant to 83 Ill. Adm. Code 451.340, three individuals with four or more years experience with enterprise financial and administration responsibilities including profit and loss responsibilities.

6. Applicant shall list, pursuant to 83 Ill. Adm. Code 451.340, three individuals with four or more years experience buying and selling power and energy in wholesale markets.

*Please see resumes of Gabriel Phillips, Jonathan Spivak, and Alex Baldassano.*

7. Applicant shall list, pursuant to 83 Ill. Adm. Code 451.340, three individuals with four years electrical system operational experience.

*Please see resumes of Gabriel Phillips, Jonathan Spivak, and Alex Baldassano.*

8. Applicant shall identify by name and job title, pursuant to 83 Ill. Adm. Code 451.340(a), the persons on its staff, and agents or contractors utilized pursuant to 83 Ill. Adm. Code 451.350, with the managerial experience required under Section 451 Subpart D.


