PETITION FOR MODIFICATION

NOW COMES the City of Streator, Illinois, and requests the Illinois Commerce Commission for the following actions:

1. Dismiss the Operating Authority granted to the City of Streator, Illinois ("City of Streator") under Docket No. 98-0654 to operate a 9-1-1 Center as the City of Streator intends to join the Livingston County 9-1-1 Emergency Telephone System Board ("Livingston County 9-1-1").
2. Recognize that the City of Streator has passed Resolution 2015/16-43 setting forth the City's desire to abandon the existing City of Streator Emergency Telephone System Board and to incorporate its 9-1-1 emergency telephone dispatch system into the Livingston County 9-1-1 System of Public Safety Answering Points ("PSAP"). A true and correct copy of Resolution 2015/16-43 is attached hereto as Exhibit A.
3. Recognize that the City of Streator has passed Resolution 2015/16-44 authorizing the execution of an Intergovernmental Agreement and, pursuant to such Resolution, the City has entered into an Intergovernmental Agreement with County of Livingston ("Livingston County") to become a member of Livingston County 9-1-1 and become a Board member of such system pursuant to Section 15.4 of the Emergency Telephone System Act, 50 ILCS 750/15.4. A true and correct copy of Resolution 2015/16-44 is attached hereto as Exhibit B and an executed copy of the Intergovernmental Agreement is attached hereto as Exhibit C.
4. Recognize that the City of Streator has passed Ordinance 2015/16-27 rescinding the authority of the Streator ETSB in the event the ICC grants permission to the City to join the Livingston County 9-1-1 system. A true and correct copy of Ordinance 2015/16-27 is attached hereto as Exhibit D.
5. Recognize that all required documents have been submitted for approval in Livingston County's Petition for Application to add the City of Streator as a joint member of the Livingston County 9-1-1.

**WHEREFORE**, Petitioner, the City of Streator, Illinois, respectfully requests that the Illinois Commerce Commission:

A. Dismiss the authority granted in Docket No. 98-0654 and approve it as a member of the Livingston County 9-1-1 Emergency Telephone System.
