RESPONSE TO NOTICE OF ADMINISTRATIVE LAW JUDGE'S RULING

On behalf of Sperian Energy Corp., Feller Energy Law Group, PLLC hereby responds to the Administrative Law Judge's ruling dated February 2, 2016 regarding Sperian Energy Corp.'s ("Movant") Petition for Confidential Treatment and Protective Order.

In response to Question 1:

- Movant no longer requests confidential treatment for Attachments A, D, and E.
- Movant requests confidential treatment for Attachment G, Managerial Qualifications, as this information is not readily available to the public, and contains proprietary information regarding Movant's business relationships. In particular, the employment history, education, and work experience of the individuals described in Attachment G are not made available to the public, and are treated as confidential by the Movant.
- Movant requests confidential treatment of Attachment H, Corporate Chart, as this information is not readily available to the public and contains proprietary information regarding Movant's business relationships. Specifically, the ownership structure of the Movant is not disclosed to the public and is treated as confidential by the Movant.

In response to Question 2:

- Movant no longer requests five-year confidential treatment of any confidential attachment designated as such. A two-year period of protective treatment is appropriate.
