

**Formal /Claim 2015-14987 With Illinois Commerce Commission
Claim Against Commonwealth Edison for Unconstitutional Refusal Fee**

1. I Quinshela Wade, file this claim against the defendants, Commonwealth Edison(ComEd), et al, with the Illinois commerce Commission (ICC),that has jurisdiction over "ComEd. This claim is timely filed.(Receive formal complaint forms March 2, 2015,)(I inform ICC I did not received the previously requested form.)
2. As a senior and is very concern about my health. I do not want smart meter on my home, since that Smart meter has been place on the surrounding homes, it has effect my health Personally. I brought that to the attention of ComEd All to no avail.
3. I am an not an attorney has no training in legalese.
4. I am incorporation all attach exhibit A, B, ^{ComEd - utility Bill} C. statements in the letter written to Commonwealth Edison (ComEd") et al, (1) **Christopher M. Crane CEO or President or Chairman of the Board or General Manager of ComEd An Exelon Company April 20, 2015, ...** (2) **To: Mr. Tom Przytulski** Commonwealth Edison 3 Lincoln Center Oak Brook Terrace, Illinois [60181], (3) **Illinois Commerce Commission** Doug Scott, chair 527 East Capitol Avenue, Springfield, Illinois [62701], (4) **Illinois, Citizens Utility Board** David Kolata Executive Director, 309 West Washington Street, Suite 800, Chicago, Illinois [60606]. (5) **Illinois Attorney General: Lisa Madigan** 500 South Second Street , Springfield, IL [62706], that is attach as part of my Claim. And copy of my ComED .
5. I will not waive my constitution rights. I rely on the Constitution and the Supreme law of the land.
6. I Timely pay my ComEd bill each month, I deduct the unconstitutional \$21.53 refusal fee each month. ComEd also place Tax on the refusal fee, that is illegal, ComEd has no legal authority to place as tax on a unconstitutional refusal fee.
7. According to The Illinois Commerce Commission it has a right to approve ComEd tariff, so long as that ComEd Tariff dose not violate Constitution rights. (The Smart Meter Refusal Fee is a violation of Constitution Rights. The refusal fee is a violation of 1st, 4th, 14th 9th, and 13th amendment constitutional right. In fact, there is no federal mandate for smart meter.
8. ComEd, nor the ICC can Forced me to comply with an unrevealed contract between ComED and ICC or any other corporations, and to which I were never a party and had no knowledge of.

9. No state or agencies including ComEd or ICC, can convert a constitution right in a privilege, Refusing smart meter on my property is my right not a privilege my refusing to Pay a smart meter refusal fee \$21.53 is my rights not a privilege.
10.

Any time a commission make a statement that \$21.53 refusal fee is a reasonable fee to deter meter refusal, is clearly a penalty assessed as a consequence of my refusal The commission recommendation of a \$21.53 "Smart Meter Refusal Charge" to deter Meter refusal is a violation of my constitution rights and not in the interests of my constitution protected rights. The Illinois Commerce Commission has exceed it jurisdiction. The Illinois Commerce Commission has no jurisdiction no to make a refusal law, to fit the benefit and need of ComED
11. Any rule regulation order and decision to uphold the unconstitutional Smart meter Refusal Fee, forcing me into excepting Smart Meter, is a crime and is out of the jurisdiction of Illinois commerce Commission 220 ILCS 5/10-201 (e)(iv)(B)west 1996).
12. Section 1, Clause 2, Supreme Law " the Constitution and the law of the united State which shall be made in pursuance thereof and all treaties made, or which shall be made under the Authority of the Unites State shall be the supreme law of the Land and the judges in ever state shall be bound thereby any Thing in the constitution of law of any State to the contrary notwithstanding."
13. ComEd", Charging me a monthly Refusal Fee of \$ 21.53 for refusing their smart meter on my house, violate my Constitution Rights.
14. The United State Supreme Court role in *Marbary V Madison states , " laws repugnant to the Constitution are automatically Null and void.*
15. The Illinois Commerce Commission has no jurisdiction to issue or uphold any law rules, regulation ordnance statute that violated my constitution rights.
16. It is unconstitutional to penalizing me by charging \$21.53 me for exercising constitutional right. And the Illinois Commerce has a duty to protect my constitutional rights as well as others, under their jurisdiction. Is the role of the commission to protect and enforce law that are in the best interest of all residents balancing property interests and common good
17. I am not a slave according to the 13 amendment of the United State Constitution. I have a constitutional protection rights to refuse smart meter without penalty, . that right outweigh any countervailing State, ICC or ComEd interest.
18. I have a constitution protection interested in refusing to pay a refusal fee, for refusing unwanted unsafe, person surveillance smart meter et al, on my home.

19. No where in the Constitution do it states I have to Pay money for freedom.
20. ComEd forcing me to except smart meter or pay a penalty take away my constitutional protected right to refuse. Where in the constitution the government can regulate a refusal?

In conclusion


