This Errata notes revisions in the Direct Testimony of Donald F. Martino and James J. Jerozal Jr. Attached to this Errata filing are revised exhibits, Nicor Gas Exs. 1.0R, 1.2R, and 2.0R.

In addition, Nicor Gas is filing a revised version of Nicor Gas Ex. 1.2 as Nicor Gas Ex. 1.2R.

- Footers: Add "R" after the exhibit number;

- At line 216, delete "\$79,176,687" and replace with "79,176,143."
