PLEASE TAKE NOTICE that pursuant to Supreme Court Rule 303(a)(3), Supreme Court Rule 335 and Section 10-201 of the Public Utilities Act, Tri-County Electric Cooperative, Inc. (Tri-County) is cross appealing to the Appellate Court of Illinois, Fourth Judicial District, the Order entered by the Illinois Commerce Commission on March 9, 2016, in the above Docket, and the denial of the Petition for rehearing on April 26, 2016. Tri-County seeks relief reversing that portion of the Order in Sections XI A, XI B, XI C, XI E, and XII denying Tri-County electric service rights under the Illinois Electric Supplier Act, 220 ILCS 30/1 et seq, and for such other and further relief as the court deems just.






