VERIFIED MOTION TO AMEND APPLICATION

Mobilitie Management, LLC (“Mobilitie Management,” or “Applicant”), by its undersigned counsel, hereby files this Verified Motion to Amend its Application for Certificate of Local Authority to Operate as a Facilities-Based Carrier of Telecommunications Services in the State of Illinois (“Application”) filed with the Illinois Commerce Commission (“Commission”) on April 7, 2016, in Docket No. 16-0251. In support of its Verified Motion, Mobilitie Management hereby states as follows:

1. In response to Section IV, page 9, question 3 of the Application, Mobilitie Management represented that it does not lease equipment and/or facilities.
2. Mobilitie Management then expanded its response to state, *inter alia*, that “[t]o the extent necessary, Applicant may partner with or resell the facilities or services of local exchange carriers, wireless providers or other companies to provide services in the state.”
3. Applicant understands that the resale of services necessitates securing a separate certificate of authority from the Commission. Applicant is not seeking such authority at this time.
4. Mobilitie Management seeks to amend its Application to reflect that it will not seek to resell services until it obtains the proper certificate from the Commission.

5. In response to Section IV, page 9, question 4 of the Application, Mobilitie Management represented that it does not resell services.
6. However, the Applicant expounded on this response to state “[t]o the extent necessary, Applicant may partner with or resell the facilities or services of local exchange carriers, wireless providers or other companies to provide services in the state.”
7. Applicant understands that the resale of services necessitates securing a separate certificate of authority from the Commission and it is not seeking such authority at this time.
8. Mobilitie Management seeks to amend its Application at Section IV, page 9, question 4 to reflect that it will not resell the facilities or services of local exchange carriers, wireless providers, or other companies until it secures the proper certificate of authority from the Commission.
9. Accordingly, Mobilitie Management files this Verified Motion to Amend Application to modify the Application’s language concerning the Company’s potential resold service offerings, and to assure the Commission that it has no intent of reselling services in the State of Illinois without first obtaining the appropriate certification.
10. Mobilitie Management, with this motion, further clarifies that the Company only seeks authority to provide facilities-based telecommunications services pursuant to its Application.

For the foregoing reasons, Mobilite Management, LLC requests the Commission permit the Company to modify and withdraw from its Application the language responding to Section IV, page 9, questions 3 and 4 concerning the company's potential resold service offerings, and grant its request for a Certificate of Authority to provide facilities-based telecommunications services.
