Ms Hessel left a message on January 6, 2014 verifying the time period she needed the records and explained why, indicating that someone was trying to collect for the utilities at 717 N Willow after she vacated the property. Our notes indicated she moved out 10/12/2004.

The water service was turned off and finalized on 10/12/2004 in the name of Hessel. On 2/10/2005 we pulled the meter and outside register prior to demolition. See Public Works for demolition information.

We are not in collections on the account. The account was paid in full on 11/1/2004. The builder or owner may have paid to clear the debt for sale or permit purposes. The tenant Hessel advised the department at that time to forward the final bill to the owner, Hillview Custom Homes Inc. The bill was paid in full as previously stated, but we have no record indicating who paid the final bill. The final bill included water, sewer and rubbish services through 10/12/2004.
