SUPPLEMENTS TO AMENDED APPLICATION

Alpha Gas and Electric, LLC ("Applicant"), hereby requests that the Illinois Commerce Commission ("Commission") grant it a certificate of service authority pursuant to Section 16-115 of the Public Utilities Act ("Act"). Alpha Gas and Electric, LLC is filing under subpart D of Part 451. In support of its application, Applicant submits the following supplements to its amended application:

1. Statement Regarding Service to Low-Income Customers

Alpha Gas & Electric certifies in the event that they bill any residential customer directly for supply, the applicant shall ensure that when marketing to residential customers who receive any type of low income energy assistance, the applicant has entered into the necessary agreements to allow low-income customers to receive Low Income Home Energy Assistance Program (LIHEAP) benefits and Percentage of Income Payment Program (PIPP) benefits. In the applicant is granted Commission authorization to provide supplier single billing to residential customers, the applicant shall ensure that, when marketing to residential customers who receive any type of low-income energy assistance, the applicant has entered into the necessary agreements to allow low-income customers to receive Low Income Home Energy Assistance Program (LIHEAP) benefits and Percentage of Income Payment Program (PIPP) benefits.

2. Supplement to ATTACHMENT 32: Explanation of Lawsuit

Description of Lawsuit against Alpha Gas and Electric, LLC:

Abramson vs Alpha Gas and Electric, LLC, No. 15cv5299 in the Southern District of New York (originally filed July 8, 2015) (class action alleging violation of TCPA rules: **Case Pending**)

- An individual is suing Alpha Gas & Electric, alleging that Alpha called individuals soliciting services without the necessary prior consent. The consumer filed an individual suit as well as a class action suit against Alpha on July 8, 2015. The suit seeks class status for those who received unsolicited phone calls from Alpha within the last four years. The case is still pending.

WHEREFORE, Applicant requests that the Commission grant its application for service authority to serve all types of retail customers in the entire service area of Commonwealth Edison Company.
