PETITION

To the Illinois Commerce Commission:

1. Petitioner, Consumers Gas Company, respectfully shows that it is a corporation duly organized and existing under the laws of Illinois and is engaged in the distribution and sale of natural gas to the public in the State of Illinois. Consumers serves approximately 5,370 customers, counting the Shawneetown and Equality, Illinois municipal systems each as one customer, in Gallatin, White and Edwards Counties.

2. It is a public utility within the meaning of an Act entitled "The Public Utilities Act" (the "Act") now in force in Illinois and is subject to the jurisdiction of this Commission.

3. The Charles A. Robinson Trust ("C.A. Robinson Trust"), a shareholder of Consumers Gas Company, owns real estate and improvements thereon located at 1410 North Cullen Avenue, Evansville, Vanderburgh County, Indiana.

4. Petitioner presently leases office space from the C.A. Robinson Trust at the described address pursuant to authority granted by this Commission in prior dockets, the most recent of which is Docket No. 13-0482.

5. The present lease terminates on September 30, 2016 and Petitioner seeks authority to enter a new lease, a copy of which is attached hereto as Exhibit GR-2 and fully incorporated by reference, with C.A. Robinson Trust of its presently leased office space.

6. The ownership of Consumers and C.A. Robinson Trust are such that an affiliated interest exists as defined in §7-101 of the Public Utilities Act.

7. The Lease, attached hereto as Exhibit GR-2, is in the public interest and the execution of same should be authorized.

WHEREFORE, all for the reasons stated above, Consumers Gas Company prays for authority to execute a Lease of office space in which an affiliated interest exists as defined under §7-101 of the Public Utilities Act.


