**PETITION  
FOR CANCELLATION OF CERTIFICATE OF AUTHORITY**

TNCI Operating Company, LLC ("Company") respectfully requests that its Certificate of Local and Interexchange Authority granted in Docket Number 13-0306 be cancelled and its tariff withdrawn, effective no later than August 31, 2016.

The Company provides the following information in support of its request:

1. The transfer of customers of TNCI Operating Company, LLC to Matrix Telecom, LLC has been officially completed and the internal restructuring of the companies, filed with the Commission in their April 18, 2016 notification, has been finalized as of June 30, 2016.
2. TNCI Operating Company, LLC states its customers are now being served by Matrix Telecom, LLC.
3. TNCI Operating Company, LLC has no presubscribed customers in Illinois and has ceased providing regulated operations in Illinois and has no plans to conduct operations in the future.
4. TNCI Operating Company, LLC does not have any outstanding obligations in the form of deposits, advance payments or prepayments.
5. Now therefore, the Company seeks to cancel all its authorities and tariffs no later than August 31, 2016.

**WHEREFORE**, TNCI Operating Company, LLC respectfully requests that the Illinois Commerce Commission grant this Petition for Cancellation of its Certificate of Authority and other relief deemed necessary by the Commission.
