3 Docket 15-0186, the Illinois Commerce Commission on
4 Its Own Motion versus People Gas Light and Coke
5 Company. This is an Investigation Into An Anonymous
6 Letter Alleging Misconduct and Improprieties Related
7 to the Peoples Gas Light and Coke Company's
8 Accelerated Main Replacement Program.

3 sorry -- December 6, 2016, and that a status be
4 convened on December 13, 2016, at 10:00 a.m., to
5 discuss such further proceedings as may be necessary.

6 JUDGE KIMBREL: Okay. Is there anything
7 further? If everyone's in agreement as to the next
8 status and the Company's filing, then I will continue
9 this matter until then. Does anybody have anything
10 to add?

11 (No response.)

12 MR. KIMBREL: No? Okay. This matter is
13 continued to December 13th, at 10:00 a.m.

14 MR. HARVEY: Thank you very much, your Honor.
