On January 11, 2002, Ameritech Illinois filed a pleading entitled, "AMERITECH ILLINOIS' SUBMISSION OF REDLINED INTERCONNECTION AGREEMENT," attached to which were multiple attachments constituting the redlined interconnection agreement. One of the attachments was incomplete, and Ameritech Illinois now corrects that error. Specifically, the redlined interconnection agreement includes a seven-page "Appendix Pricing," which, in turn, incorporates two attached Pricing Tables: an eleven-page table with a header in the upper right-hand corner that reads "Appendix Pricing Ameritech/CLEC"; and an eight-page table with a header in the upper right-hand corner that reads "Appendix Pricing AIT-IL/CLEC Collocation Services." The redlined interconnection agreement as Ameritech Illinois previously filed it omitted the latter of those two Pricing Tables. Ameritech Illinois now corrects its error by submitting the attached Appendix Pricing, which includes the "Appendix Pricing AIT-IL Collocation Services" Pricing Table that was omitted from the previous filing.
