1. Now Comes Frank G. Saladino, Pro-Se, stating that the above case after being studied by Attorneys will be appealed, and for what is believed to be prejudicial treatment, and filed in Federal Court.
2. We do not feel that the Illinois Commerce Commission needs anymore proof then Electric was refused to the Plaintiff, whether he is Black, White, or any color or Nationality.
3. Stated in the Transcript and is proved that the Judge ordered Plaintiff and Defendant to give discovery to each other, and the Plaintiff did and Defendants have not, which breaks the Court order of the Commerce Commission.
4. This is a Default, and to say that is now being rescinded for the Defendants Benefits is Prejudicial.
5. An Amended Complaint, we believe, allows for new parties to be added.

6. For the Judge to not want to see any documents or read anything would leave this Complaint Blank, the fact of whether it is the N.A.A.C.P. or the Plaintiff or the Buyer of the property, still does not take away that Commonwealth Edison at a hearing, which has been stated numerous times, that there was never a plan given to them when by an accident a very large Electrical Plan fell out of their files, and was recognized by the Plaintiff, the Electrical Contractor, and everyone in the room, which proved them lying on the spot about not having the plans, and proved that they had the plans and would not give Electric for whatever reason.
7. We spoke of Transformers, they are not near the property, they are on the property, as you well know, now, it was stated by we will use C.E. for (Commonwealth Edison), that the Transformers no one has to pay rent because they were given to the Owners of the property for a building, they intended to build but never build, when the Owners came to build, they were told, there are no Transformers, which is it? The Transformers are visible, when can we stop this lying? The Plaintiff is familiar with the Commerce Commission, where are the investigators? That should have been sent out to see what is right or wrong for the protection of whomever.
8. Everybody had to give there name, but not the Mystery Person, whom we take it is with C.E..
9. Cannot let us going on records with accusations, that are outside the legal theory in our Complaint, because accusations have no place in Court. This is more than accusations.
10. An ugly racial epithet cannot ruin a business venture, well, that ugly remark showed that you are prejudice, and did not want to give Electric. How do you sell, why should you buy? If you cannot have lights, etc. that's how it affected me.
11. You cannot recover for injury to anyone but your self, that is what I am trying to do, unfortunately the use of racial slurs is not necessarily legal---illegal, then racial slurs can violate the Law. Stated, I do not tolerate racial slurs, eight months going on ten months it is being tolerated, and looks like it want to go out the door.
12. You keep asking what we want C.E. to do about it, pay damages, they lie right at the table, we had Lawyers contacted them, and were told that C.E. laughed at them, they even lied that they spoke to Attorney, right in front of Your Honor.
13. The Doors and Gates are open, the damage has been done, what to do is pay damages again.

14. C.E. given permission to Cable and Phone Companies to run lines, what do you mean by on whose property? My Property, I am not Complaining about the person across the street, how does that affect me? Well, lets give permission for C.E. to get three big trucks per day drive it on all over on your property in your back yard, and we will see how that affects you.
15. C.E. giving permission to Cable and Phone Company to run lines, on whose property, and how does that affect me? Its my Property, and it affects me by then you cannot put a building on their lines.
16. You stated there is no Law about a Verbal Contract to purchase Land, the Verbal Contract was given because the money being asked for repairing roads, rent, and the Plaintiff was told that the price of them would be all included in their purchase price.
17. Damages to Real Estate, you asked what C.E. can do to fix it, you know they can give you money damages was stated, yes I know, but they will not.
18. The Constitution where the Public Utility Acts was violated, try by not giving you Electric period. Its not for lack of money, or anything, I don't see any reason, so, why?
19. There is a Letter by Paul Calighan from C.E. where at the hearing numerous sentences proved to be lies. Discovery get suspended, when C.E. gets in trouble, we have a right to talk, you said, we have a right to request, where?
20. You do not want any proof, any documentation, etc. and its stated that is the legal system, and then states that you do not have enough facts to know what it is, that were proving, an order to get to the proof you need enough facts to know what is being tried to prove, if you don't want to see the damage roads, pictures, eight months of confusion.
21. A Complaint that has enough facts, it could be no surprises, well if you don't want any proof, there will not be any surprises. Seeing damages for your trespass to your Real Estate is different than ordering C.E. Employees not to trespass.
22. You asked how C.E. Employees leaving Doors and Gates open, how does that affects me, you already answered that Judge.

23. There are numerous statements in this transcript, and the length of time for us to allege that its going nowhere for whatever reason. I asked for transcript, and when I had C.E. backed in to a corner you told the Court Reporter to turn it off.
