**PETITION OF PEOPLES ENERGY SERVICES CORPORATION**

**To the Administrative Law Judge:**

Pursuant to 83 Illinois Administrative Code §200.200, Peoples Energy Services Corporation (“PE Services”), by one of its attorneys, Timothy P. Walsh, hereby petitions this Commission for leave to intervene in the above-entitled cause, and in support of this petition states as follows:

1) PE Services is a corporation organized and existing under the laws of the State of Illinois and is principally in the business of providing energy services to retail customers. This currently includes sales of electricity and of natural gas and natural gas management services to Illinois commercial and industrial end users. The Commission certified PE Services as an “alternative retail electric supplier” (“ARES”), as that term is defined in §16-102 of the Public Utilities Act, in Docket 99-0432 on September 14, 1999.

2) The purpose of this proceeding is for the Commission to consider Commonwealth Edison Company’s above-captioned petition. As an ARES PE Services has an interest in this proceeding, and its interest is not adequately represented by any party to this proceeding.
