


## 5. ORGANIZATION CHART





AMENDMENT TO RESOLUTION DT-0025-99  
CH 43 COUNTY FARM ROAD – SECTION 99-00179-10-BD  
(INCREASE CONTRACT \$15,692.91 +13.85%)

WHEREAS, the DuPage County Board has heretofore adopted Resolution DT-0025-99, dated April 13, 1999 for CH 43 County Farm Road, Section 99-00179-10-BD; and

WHEREAS, at that time it was determined that the cost of said project to the County of DuPage, by and through the DuPage County Division of Transportation, would be \$113,272.83; and

WHEREAS, a contract was awarded by County Board Resolution DT-0025-99 to River City Demolition for said project; and

WHEREAS, the house at 25 W 561 Evelyn Avenue was acquired after said project was awarded and with the concurrence of the Transportation Committee was added to the work; and

WHEREAS, additional quantities of contract restoration items are required to complete the work; and

WHEREAS, it has now been determined that the cost now equals \$128,965.74; and

WHEREAS, said project is provided for in the 1999 budget for the DuPage County Division of Transportation; and

WHEREAS, said cost may lawfully be paid from available highway funds; and

WHEREAS, Resolution DT-0025-99 encumbered certain monies for payment of the costs of Section 99-00179-10-BD as follows:

WHEREAS, it is desirable to adjust the funding of the above named project.


