PETITION FOR LEAVE TO INTERVENE

The City of Waterloo, Illinois, a municipal corporation, hereinafter referred to as "Waterloo", by its attorneys, Crowder & Scoggins, Ltd., moves for leave to intervene herein, and in support thereof states as follows:

1. Waterloo is a municipal corporation organized and existing under the laws of the State of Illinois and situated in Monroe County, Illinois.




