The People of the State of Illinois, by JAMES E. RYAN, Attorney General of Illinois (hereafter "People"), hereby file their Reply Brief in the above referenced matter.

REPLY TO COMED

ComEd attached a proposed Draft Order to its Initial Brief. The People, in their Initial Brief, requested "the Commission enter an order which makes clear that any approval of the proposed transaction is dependent on the exact terms and conditions contained in the agreements attached to ComEd's Notice, and that its order can in no way be construed as an acceptance or erstwhile approval of any of the terms and conditions contained in the agreements attached to ComEd's Notice." Peoples In. Br. at 5. To the extent that ComEd's proposed Draft Order does not reflect the People's requested relief, they urge the Commission to reject ComEd's proposed Draft Order and enter an order which does include the above cited relief.

CONCLUSION

WHEREFORE, for the reasons set forth above, the People respectfully request the Commission enter an order in the manner requested in their Initial Brief.




