Environmental Disclosure Statement

The disclosure of this information is required under Section 16-127 of the Electric Service Customer Choice and the Rate Relief Law of 1997 and the rules of the Illinois Commerce Commission, 83 Ill. Admin. Code 421.

Santanna Energy Services purchases all of its electricity from the wholesale power market. The information contained herein is based on PJM System Mix – System Data. The tables below represents our best estimates based on similar product data within the region. Santanna Energy Services reports fuel sources and emissions data from PJM to its customers quarterly, allowing customers to compare data among the companies providing electricity service in Illinois.






