1 PROCEEDINGS

2 CHAIRMAN SCOTT: Pursuant to the provisions
3 of the Open Meetings Act, I now convene a regularly
4 scheduled Bench Session of the Illinois Commerce
5 Commission. With me in Springfield is Commissioner
6 Colgan. With us in Chicago are Commissioner McCabe
7 and Commissioner del Valle. I am Chairman Scott. We
8 have a quorum.

9 Before moving into the agenda, according to
10 Section 1700.10 of Title 2 of the Administrative
11 Code, this is the time we allow members of the public
12 to address the Commission. Members of the public
13 wishing to address the Commission must notify the
14 Chief Clerk's office at least 24 hours prior to
15 Commission meetings. According to the Chief Clerk's
16 office, we have no requests to speak at today's Bench
17 Session.

18 Turning to the Transportation Agenda, we'll
19 begin with the approval of minutes from our July 30th
20 Bench Session. I understand amendments have been
21 forwarded.

22 Is there a motion to amend the minutes?

23 COMMISSIONER COLGAN: So moved.

24 CHAIRMAN SCOTT: Is there a second?

1 COMMISSIONER McCABE: Second.

2 CHAIRMAN SCOTT: Moved by Commissioner
3 Colgan; second by Commissioner McCabe. All in favor
4 say aye.

5 (Chorus of ayes.)

6 CHAIRMAN SCOTT: Any opposed?

7 (No response.)

8 CHAIRMAN SCOTT: The vote is four to nothing
9 and the amendments are adopted.

10 Is there now a motion to approve the minutes
11 as amended?

12 COMMISSIONER DEL VALLE: So moved.

13 CHAIRMAN SCOTT: Is there a second?

14 COMMISSIONER COLGAN: Second.

15 CHAIRMAN SCOTT: Moved by Commissioner del
16 Valle; second by Commissioner Colgan.

17 All in favor say aye.

18 (Chorus of ayes.)

19 CHAIRMAN SCOTT: Any opposed?

20 (No response.)

21 CHAIRMAN SCOTT: The vote is four to nothing
22 and the minutes from our July 30th Bench Session, as
23 amended, are approved.

24 Items RR-1 through RR-6 can be taken

1 together. These items are Petitions for
2 Authorization to construct various safety improvement
3 projects at railway crossings in Kankakee, White,
4 Kane, Cook, Will, and Madison Counties. The ALJ in
5 each case recommends entry of an Order granting the
6 petition.

7 Is there any discussion?

8 (No response.)

9 CHAIRMAN SCOTT: Is there a motion to enter
10 the Orders?

11 COMMISSIONER COLGAN: So moved.

12 CHAIRMAN SCOTT: Is there a second?

13 COMMISSIONER McCABE: Second.

14 CHAIRMAN SCOTT: Moved my Commissioner
15 Colgan; second by Commissioner McCabe.

16 Any discussion?

17 (No response.)

18 CHAIRMAN SCOTT: All in favor say aye.

19 (Chorus of ayes.)

20 CHAIRMAN SCOTT: Any opposed?

21 (No response.)

22 CHAIRMAN SCOTT: The vote is four to nothing
23 and the Orders are entered. We will use this four to
24 nothing vote for the remainder of today's

1 Transportation Agenda unless otherwise noted.

2 Item RR-7 is Docket Number T14-0053. This
3 is the City of East St. Louis' Petition for Approval
4 of the taking of certain property by exercising
5 eminent domain authority. ALJ Duggan recommends
6 entry of an Order authorizing the initiation of
7 eminent domain action.

8 Is there any discussion?

9 (No response.)

10 CHAIRMAN SCOTT: Any objection?

11 (No response.)

12 CHAIRMAN SCOTT: Hearing none, the Order is
13 entered.

14 Items RR-8 through RR-13 can be taken
15 together. These items are Stipulated Agreements
16 seeking authorization for safety improvement projects
17 at highway-rail grade crossings across Illinois. In
18 each case, our Transportation Staff recommends entry
19 of an Order or Supplemental Order granting the
20 requested relief.

21 Is there any discussion?

22 (No response.)

23 CHAIRMAN SCOTT: Any objections?

24 (No response.)

1 CHAIRMAN SCOTT: Hearing none, the Orders
2 are entered.

3 On to Motor Carriers. Item MC-1 is Dazzo's
4 Auto Repair's Application for renewal of their
5 Commercial Relocation Towing License pursuant to the
6 provisions of Section 18a-401 of the Illinois
7 Commercial Relocation of Trespassing Vehicles Law.
8 The Transportation counsel recommends entry of an
9 Order granting the renewal.

10 Is there any discussion?

11 (No response.)

12 CHAIRMAN SCOTT: Any objections?

13 (No response.)

14 CHAIRMAN SCOTT: Hearing none, the Order is
15 entered.

16 Mr. Matrisch, is there any further business
17 to come before the Commission today?

18 MR. MATRISCH: No, Chairman. Thank you.

19 CHAIRMAN SCOTT: Hearing none, that
20 concludes the Transportation Agenda. Thank you,
21 gentlemen.
